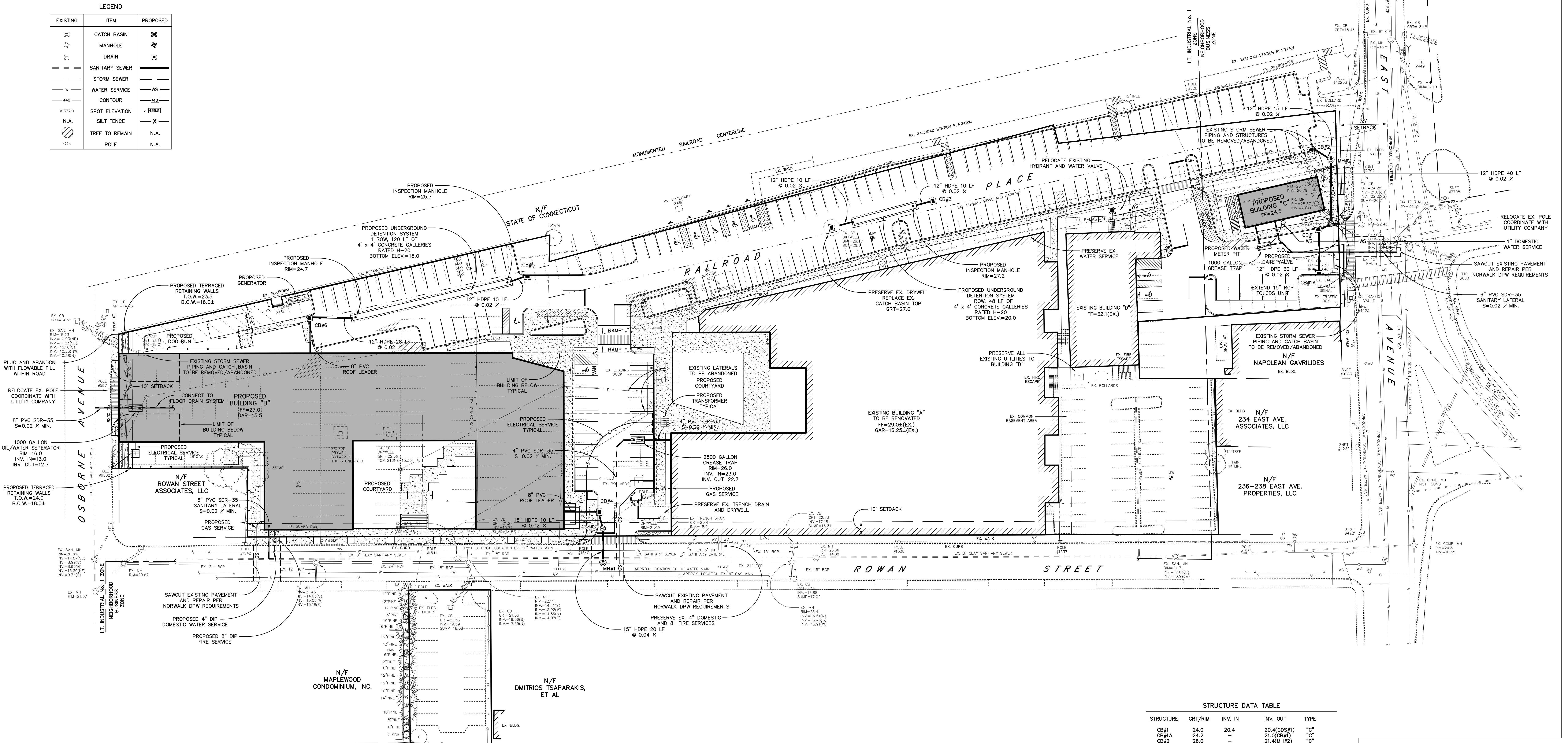
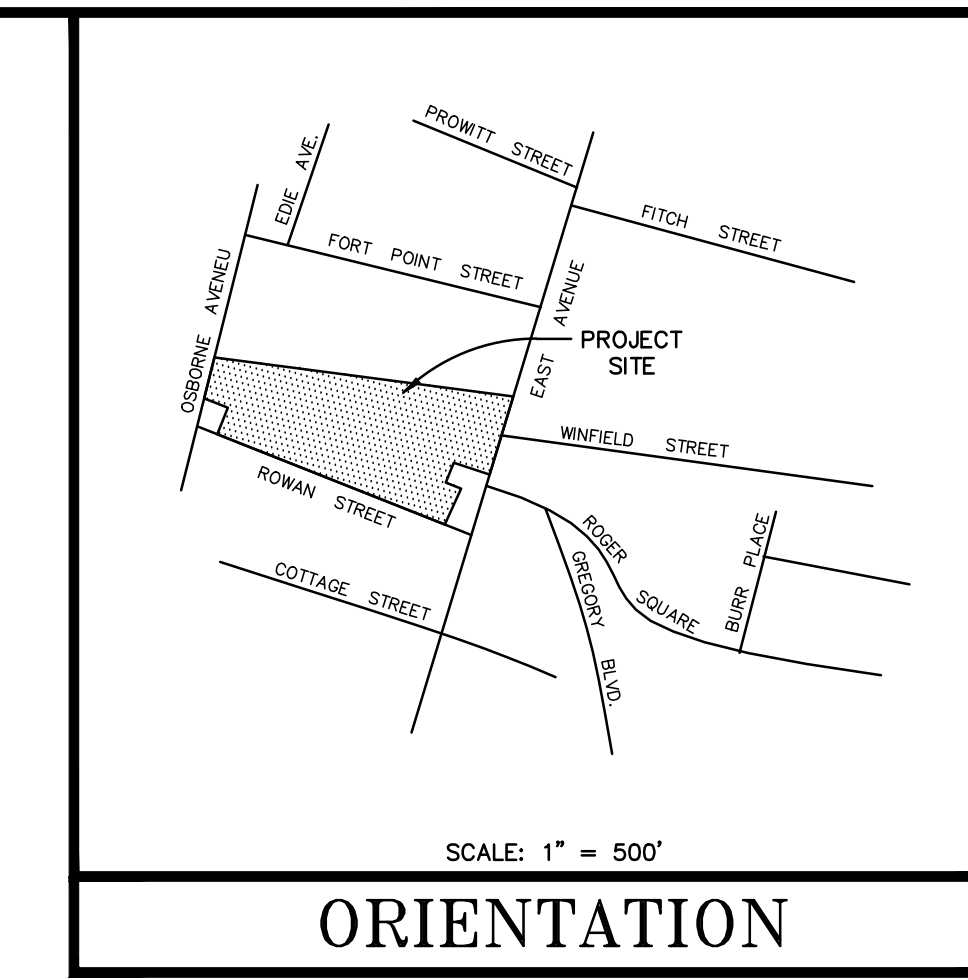


**NOTES:**

- THE PURPOSE OF THIS PLAN IS TO INDICATE THE PROPOSED SITE UTILITIES REQUIRED FOR RENOVATION OF THE EXISTING BUILDING "A" AND CONSTRUCTION OF NEW BUILDINGS "B" AND "C".
- ALL CONSTRUCTION SHALL CONFORM TO THE CITY OF NORWALK STANDARD DETAILS AND SPECIFICATIONS, IN THE ABSENCE OF LOCAL STANDARDS, THE WORK SHALL CONFORM TO THE REQUIREMENTS OF THE CONNECTICUT DEPARTMENT OF TRANSPORTATION SPECIFICATION FORM B17, LATEST REVISION.
- ALL WORK WITHIN THE STREET RIGHT-OF-WAY SHALL BE COORDINATED WITH THE CITY OF NORWALK DEPARTMENT OF PUBLIC WORKS.
- ALL UTILITY CONNECTIONS SHALL BE COORDINATED WITH THEIR RESPECTIVE UTILITY PROVIDER.
- THE CONTRACTOR IS RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS PRIOR TO THE COMMENCEMENT OF THE WORK.
