#### **CALL TO ORDER**

Chairman O'Connor called the meeting to order at 4:10 p.m.

#### POLICE COMMISSION AGENDA

#### APPROVAL OF THE MINUTES OF DECEMBER 2008

#### **DECEMBER TRAINING REPORT**

Chief Rilling briefly reviewed the December Training Report with the Commissioners.

#### **DECEMBER 2008 OFFICERS OF THE MONTH**

(Lieutenant Thomas Mattera, Detective David Orr, Detective Tim Marquis)

Chief Rilling reviewed the details of the police response to a threat of suicide in December. The officers were able to calm the victim enough to approach and remove the victim from the precarious perch and turn the victim to medical personnel for appropriate treatment.

The Mayor commented that he had monitored the situation via his police radio and was very impressed with the level of professionalism and superior coordination shown by the officers in averting this tragedy. He expressed his sincere thanks to the officers.

The Commissioners then presented the officers with Certificates for their excellent work in handling this situation.

### 2008 OFFICER OF THE YEAR

(Officer Garrett Kruger)

The Chief reviewed the details surrounding the police department's response to a call regarding a resident who had been threatening suicide with a gun. Officer Kruger and three other officers arrived at the scene. Officer Kruger was able to engage the attention of the victim long enough to allow the other officers to take up positions. When charged by the victim who was holding a weapon, Officer Kruger held his ground and fired his Taser, as did the other officers. Following this, the officers were able to subdue the victim and allow the victim to receive the needed medical attention.

Chief Rilling commented that although there has been much in the press regarding the safety of Tasers, the Norwalk Police Department has found them to be effective in preserving the lives of those who have become combative and uncooperative. He said that he believes that Tasers have saved the lives of more people than they have harmed.

Officer Kruger was then presented with a 2008 Officer of the Year plaque by the Commissioners and the Chief. Following this, Union President Roncinske presented Officer Kruger with a gift certificate from the Union.

Chief Rilling then presented the 2008 Perfect Attendance list to the Commissioners for their inspection.

The Commission moved to the Traffic Authority Agenda at 4:22 p.m.

## MODIFICATION TO ON-STREET PARKING ON WALL STREET – PROVIDE ANGLED PARKING SPACES FROM ISAAC STREET WEST TO THE GLOBE THEATER.

Mr. Yeosock came forward and displayed an aerial photo of the area bordered by intersection of Wall Street with West Avenue, the intersection of Wall Street and River Street, the Isaac Street Parking lot and Bunnell Boulevard. The photograph included an overlay showing angled parking on the south side of Wall Street from the Globe Theater to Isaac Street.

Mr. Yeosock stated that the Fairfield County Bank will lose their parking when POKO Partners begin to dig up the Isaac Street parking lot and that angled parking has been requested on Wall Street to compensate for the loss. Mr. Yeosock explained that this was merely a submission of the request and information. He said that he would like a full discussion at the March Commission meeting.

Strong concerns were expressed about having cars back out into traffic on Wall Street and pedestrian safety. Having Wall Street turned into a one way street from West to Summer was also briefly mentioned.

## MODIFICATION OF ON-STREET PARKING ON SYCAMORE PLACE – POST NO PARKING ANYTIME ON THE NORTH SIDE OF SYCAMORE STREET FROM PINE HILL AVENUE TO THE WEST SIDE OF NO. 11 SYCAMORE.

Mr. Yeosock came forward and displayed an aerial photo of the area and reviewed the details of the situation with the Commission. Mayor Moccia commented that he had received numerous calls and emails regarding this issue. He added that he supported the placement of the signs, but wished to have the neighbors notified regarding this. Mr. Yeosock said that this could be done.

#### SONO HOTEL, 33-41 SOUTH MAIN STREET

Atty. Suchy came forward with representatives from the developer and from Beinfield Architects and greeted the Commission. Chief Rilling explained that he had met with Atty. Suchy and the developers to discuss concern issues about the construction of the hotel next to the Police Department and all his questions had been answered satisfactorily.

Atty. Suchy explained that the proposed hotel would be eight stories tall with valet parking on the second and third floors. This building would be very similar to the one in Stamford on Summer and Broad Streets. Atty. Suchy then reviewed the reconfiguration of the parking on South Main and explained that an easement from the Police Department

would be needed to allow emergency vehicles access to the back of the building. This would entail the loss of one parking space at the rear of the public parking lot for the Police Department. Copies of the proposed plan along with a proposed easement were then distributed to the Commissioners. Atty. Suchy said that the developers were looking for authorization for the 8-24 request to be submitted to Planning and Zoning and that a public hearing on the hotel was anticipated in March.

Mayor Moccia commented that he had gone to Stamford to see the facility and was quite impressed. He added that apparently the Stamford Courtyard was rated as Number 2 of all the Courtyard Hotels.

This concluded the business of the Traffic Authority, so the Commission then returned to the Police Commission Agenda.
