Chief Kulhawik stated that during the early morning hours of May 15, 2018, Sgt. Mosher, Officer Claver-Obinna, and Officer Yenkelun were dispatched to a crash in the area of Ryan Avenue. The occupants of the vehicle had fled the scene on foot. He stated that the officers responded and coordinated the investigation and search which resulted in the location of two suspects related to the investigation in the area. Chief Kulhawik stated that further investigation and further in-depth investigation and interviews by Det. Collins resulted in the subsequent arrest of 6 juveniles for a total of 13 burglaries along with other charges.
